During registration the user is required to give his/her personal data.

The data are stored in a data base and treated according to Art.7 – Code concerning the protection of personal data – Decree dated 30/06/2003,n.196.

WHY PERSONAL DATA ARE NEEDED AND HOW THEY ARE USED.

RIGHTS OF THE USER.

According to this Art., the user has the right to obtain :
